CITY OF BOX ELDER ORDINANCE # 738 TO AMEND THE 2023 BUDGET

BE IT ORDAINED BY THE Common Council of the City of Box Elder as follows:

SECTION 1- PURPOSE.

Ordinance # 738 is an ordinance amending Ordinance # 729 that amended the adopted 2023 Appropriation for the City of Box Elder. The Common Council of the City of Box Elder has deemed this ordinance to be reasonable and necessary to discharge its lawful duty to make, approve and adopt a supplemental appropriation ordinance, providing for appropriations for which no provision has been made in the annual appropriation ordinance for fiscal year 2023.

SECTION 2 – SUPPLEMENTAL APPROPRIATION OF FUNDS

The Council hereby allocates and appropriates an additional amount as follows: \$-340,311.26 for the General Fund (101-4100,101-4141,101-4142,101-4143,101-4211,101-4311,101-4312,101-4313,101-4314,101-4521, and 101-4652); -\$81,295 for Promoting the City (211-4801); \$-417,550 for BID #1 & #2 (Fund 213-4800 and 213-4807); -\$6,374,181.90 for Capital Improvement Projects (501-9001 through 501-9046); -\$217,793.00 for Water (602-4335 through 4460); -\$491,558.00 for Wastewater (604-4321); \$26,035.00 for Solid Waste (Fund 612-4323); and -\$575,500.00 (Fund 755-4100).

SECTION 3 – NEW ADJUSTED BUDGET AMOUNTS
