A RESOLUTION APPROVING THE CITY OF BOX ELDER'S COST SHARE COMMITMENT FOR THE SOUTH DAKOTA LAND AND WATER CONSERVATION FUND GRANT

WHEREAS, the United States of America and the State of South Dakota have authorized the making of grant from the Land and Water Conservation Fund (LWCF) to public bodies to aid in financing the acquisition and/or construction of specific outdoor recreation project; and

WHEREAS, the City of Box Elder, South Dakota intends to submit a Land and Water Conservation Fund (LWCF) Grant application to the South Dakota Department of Game, Fish & Parks, Division of Parks and Recreation for improvements to Denali Park.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Box Elder, that:

- That the Mayor of Box Elder is hereby authorized to execute and file an application on behalf of the City of Box Elder, South Dakota with the National Park Service, U.S.
 Department of Interior, through the State of South Dakota, Department of Game, Fish and Parks, Division of Parks and Recreation, for an LCWF grant to aid in financing the Denali Park Improvement Project of the City of Box Elder, South Dakota and its Environs.
- 2. That the Mayor of Box Elder is hereby authorized and directed to furnish such information as above mentioned federal and/or state agencies may reasonably request in connection with the application which is hereby authorized to be filed.
- 3. That the City of Box Elder shall provide a minimum of 50% of the total cost of the project, up to and including \$103,500 (both in City designated cash and/or in-kind labor/equipment); and will assume all responsibility in the operation and maintenance of the project upon completion of construction, for the reasonable life expectancy of the facility.
