

Project Update: May 9, 2024

Prairie Road Reconstruction: Phase 1

Project Summary:

• Reconstruction of Prairie Road. This includes a new asphalt surface, sidewalk, and storm sewer for improved drainage. This will be the first of two phases. Phase I will extend from Pride Court to Swallow Drive.

Updates:

• The ditch on north side of Falcon Drive and Prairie Road has been re-worked. The area inlet is installed, and the area will be finished by end of the week.

Upcoming Schedule:

• An additional walk-through will be conducted to ensure all punch list items have been addressed.

Completion Dates:

- Substantial completion date: 11/17. Road paved and usable.
- *Final Completion date*: Spring 2024. All construction tasks are complete including seeding and cleanup. A final walkthrough inspection will then be conducted by the city, a few corrections or repairs may be identified that the contractor will need to address.

Prairie Road Reconstruction: Phase 2

Project Summary:

 Reconstruction of Prairie Road. This includes a new asphalt surface, sidewalk, and storm sewer for improved drainage. This will be the second of the two phases. Phase 2 will extend from Swallow Drive to 225th Street. Phase 2 consists of installing box culverts at the creek crossing to address known flooding issues in the area.

Updates:

- *Please keep out of the worksite*
 - Quinn Construction has observed children cutting through the worksite and crossing the creek.
- Storm sewer installation continues along the north section of Prairie Road.
- Fire hydrant on Westwind Rd intersection has been re-located.
- Quinton Lane Intersection storm sewer and service lines have been installed.

Upcoming Schedule:

- Installing storm sewer to the box culverts.
- Connecting storm sewer to the box culverts.
- Backfilling of the box culverts.
- Removing existing asphalt.
- Installation of storm sewer north of Westwind Drive. The road will be closed at Westwind Drive intersection with Prairie Road for the week.

Completion Dates:

- Substantial completion date: 9/27/2024. Road paved and usable.
- Final Completion date: 10/25/2024.

Sidewalk Improvement: Phase 2

Project Summary:

• This project is in addition to the sidewalk along Elsworth Road. Phase 2 will start just north of Cimarron Drive and go south to Hwy 14/16. There is an additional section that will be completed first along Tower Road that will connect Ballista Blvd to Pershing St sidewalks.

- Work on subgrade continues between I-90 overpass and Hillview Drive.
