# CITY OF BOX ELDER ORDINANCE # 714 TO SUPPLEMENT THE 2022 APPROPRIATION ORDINANCE

BE IT ORDAINED BY THE Common Council of the City of Box Elder as follows:

SECTION 1- PURPOSE.

Ordinance # 714 is an ordinance amending Ordinance # 699 that amended the adopted 2022 Appropriation for the City of Box Elder. The Common Council of the City of Box Elder has deemed this ordinance to be reasonable and necessary to discharge its lawful duty to make, approve and adopt a supplemental appropriation ordinance, providing for appropriations for which no provision has been made in the annual appropriation ordinance for fiscal year 2022.

## SECTION 2 – SUPPLEMENTAL APPROPRIATION OF FUNDS

The Council hereby allocates and appropriates an additional amount as follows: \$1,191,503 for BID #1 & #2 (Fund 213-4800 and 213-4807); \$77,428 for Wastewater (604-4321); \$19,167 for Solid Waste (Fund 612-4323); and \$370,444 (Fund 755-4100).

#### SECTION 3 – NEW ADJUSTED BUDGET AMOUNTS

The Council hereby deems the new adjusted budget amounts per the appropriations and allocations changes by department:

\$8,837,152 (General Fund 101-0000); \$491,938 (Promoting the City Fund 211-4801); \$2,213,501 (BID #1 & #2 Fund 213-4800,4807); \$2,601,609.17 (Capital Projects Fund 501-0000, 501-9001 through 501-9026); \$3,022,350 (Water Fund 602-4335); \$1,998,235 (Wastewater Fund 604-4321); \$413,750 (Solid Waste Fund 612-4323); \$660,000 (TIF Fund 755-0000).

NOW THEREFORE, BE IT FURTHER ORDAINED by the Common Council of the City of Box Elder that the above supplemental appropriations to the 2022 Appropriation Ordinance are hereby adopted. This Ordinance shall become effective immediately upon passage in accordance to SDCL § 9-19-13.
